PRIVACY POLICY

I. INFORMATION THAT MAY BE COLLECTED FROM YOU

We may collect the following information:

- name, gender, age and;
- contact information including email address;
- demographic information such as country of residence, pincode, city;
- such other information as may be required as per our registration process.

We may also collect the following information:

• about the pages you visit/access;

- the links you click on the Application;
- the number of times you access a particular page; and
- the number of times you have interacted on the Application.

We automatically collect the following information:

- IP address
- your browser type
- language
- device access time

Cookies:

In an effort to improve the quality of our Application, we track information provided to us by your device when you view or use the Application, such as the applications you came from, the type of browser you use, the device from which you connected to the Application, the time and date of access, and other information that does not personally identify you.

We track this information using cookies or small text files which include an anonymous unique identifier to enhance your experience. Cookies are sent to a user's browser from our servers and are stored on the user's device for record-keeping purposes and sometimes to track information about them. Sending a cookie to a user's browser enables us to collect information about that user and keep a record of the user's preferences when using our Application .
